### “A Resolution Honoring Cedarburg School Superintendent Dr. Daryl Herrick”


- WHEREAS,** Dr. Daryl Herrick began his employment as School Superintendent with the Cedarburg School District in 2001; and
- WHEREAS,** during his twelve years as Superintendent, Dr. Herrick has conscientiously and capably served the Cedarburg School District and the Cedarburg Community; and has demonstrated the highest principles of education while exhibiting high moral and ethical standards; and
- WHEREAS,** during Dr. Herrick's tenure the Cedarburg School District has earned a spot as one of the Top 10 school districts in America;
- WHEREAS,** during Dr. Herrick's service, Forbes ranked Cedarburg School District as one of the best in providing quality education in relation to the value of homes in the area; the Public Policy Forum ranked the Cedarburg School District 2<sup>nd</sup> in the 51 school districts in Southeastern Wisconsin three consecutive years; the Cedarburg School District was one of five Wisconsin high schools nationally ranked by US News and World Report; Cedarburg High School placed on the 3<sup>rd</sup> Annual AP District Honor Roll by the College Board for simultaneously increasing access to Advanced Placement course work while increasing the percentage of students earning scores of three or higher on AP exams; and the ACT composite scores are the highest in the history of the school district with an average composite ACT of 25.2 and 85% of students taking the test; and
- WHEREAS,** the following are major accomplishments of Dr. Herrick's tenure, just to name a few: developing state of the art school and community facilities, including expansion to a Field House, expansion of Westlawn Elementary School, renovation of all classrooms at Westlawn, construction of a new football/track stadium, construction, expansion, and renovation of sports facilities; facilitating technological advances such as connecting schools by a high-speed fiber optic network, implementing a high-speed wireless environment in all schools, equipping the schools with state of the art computers, software and technology; assisting in the development of the Cedarburg Basketball Club; assisting with the creation of the Cedarburg Education Foundation, and developing the Hall of Fame; and
- WHEREAS,** Dr. Herrick demonstrated sound judgment and decision-making in matters involving the Cedarburg School District; and his integrity, courtesy, and professionalism earned him the respect of the community, his co-workers, and peers; and
- WHEREAS,** the Cedarburg Community has benefited significantly from the dedication, knowledge, skills, service, and excellence in education of Dr. Herrick;
