

**TOWN OF CEDARBURG
ORDINANCE NO. 2008-21**

An Ordinance to Amend Section 16-6. Park and Open Space Committee, of the Town of Cedarburg Code of Ordinances, Ozaukee County, Wisconsin.

WHEREAS, Wisconsin State Statutes Section 60.66 enables a township to establish a Town Park Commission; and,

WHEREAS, the Town has decided to decrease the size of the existing Park & Open Space Committee from seven members down to five members including four Town of Cedarburg citizen members and one Town Supervisor,

NOW, THEREFORE, BE IT ORDAINED by the Town Board of the Town of Cedarburg, Ozaukee County, Wisconsin, that the following sections of Chapter 16 of the Town of Cedarburg Code of Ordinances are hereby amended to read as follows:

§ 16-6. Park and Open Space Committee.

[Added 9-7-2005 by Ord. No. 2005-9]

- A. Name. There is hereby created and established a ~~Park and Open Space~~ Town of Cedarburg Park Committee (hereinafter "Committee"). Said Committee shall have all the powers hereinafter enumerated.
- B. How constituted.
- (1) The Committee shall be composed of ~~six~~ four Town of Cedarburg citizen members and one Town Supervisor.
 - (2) The citizen members shall be appointed by the Town Chairperson with the majority approval of the Town Board and shall be appointed for three-years terms in April.
 - (3) The Supervisor member of the Committee shall be appointed by the Town Chairman with the majority approval of the Town Board in April of each year.
 - (4) Insofar as practical and with due regard to the qualifications, the citizen members shall be from different parts of the Town of Cedarburg.
- C. Meetings.
- (1) The Committee shall hold regular monthly meetings on the third Tuesday of every month, to be held at Town Hall (1293 Washington Avenue) at 7:00 p.m.
 - (2) The Town Administrator shall serve as the staff liaison for the Committee meetings.
 - (3) A Town clerical employee shall serve as the Secretary of the Committee and shall keep minutes of all proceedings as required by current Wisconsin Statutes.

D. General duties.

(1) In an advisory capacity to the Town Board, the Committee shall undertake the planning, development, acquisition, expansion, disposition, maintenance and use of all parks ~~in open spaces and natural areas and facilities and other similar public property under the jurisdiction of the Town of Cedarburg.~~

(2) The Committee shall work to provide the broadest community benefit in its provision of parks ~~and open spaces~~ in the Town and shall act to sustain, enhance and preserve the natural resources of the Town of Cedarburg.


(3) The Committee shall make recommendations to the Town Board when it deems appropriate to make application for grant funds from state agencies for the purpose of creating or enhancing the Town's parks ~~and open spaces~~ and related facilities.
