

**TOWN OF CEDARBURG
ORDINANCE NO. 2009-6**

An Ordinance amending Section 305-8, reducing the speed limit on sections of Cedar Creek Road.

WHEREAS, the Town of Cedarburg has legal authority by Wisconsin State Statute 349.11(3)(c) to reduce statutory speed limits on Town roads; and

WHEREAS, the Town Board believes it to be in the best interest of the Town to reduce the speed limit on sections of Cedar Creek Road as specified below due to local conditions; and,

WHEREAS, the Town Board believes reducing these specified speed limits works to protect the health, safety and welfare of Town Residents;

NOW, THEREFORE, be it ordained by the Town Board of the Town of Cedarburg, Ozaukee County, Wisconsin, that the following sections of Chapter 305, Vehicles and Traffic, of the Town of Cedarburg Code of Ordinances are hereby amended to read as follows:

§305-8. Speed Limits

B. Speed limits increased or established. The speed limits are increased or established as hereinafter set forth in this subsection upon the following streets or portions thereof between the limits designated:

(1) A speed limit of 45 miles per hour on the following highways:

Name of Street	Location
Bridge Street [Amended 1-7-2008 by Ord. No. 2008-3]	From Granville Road west to the line separating Ozaukee County and Washington County
Cedar Creek Road [Added 1-7-2008 by Ord. No. 2008-1]	Between CTH NN and Covered Bridge Road to <u>the Ozaukee/Washington County Line</u>
Cedar Creek Road	Between Hy <u>CTH I</u> and Maple Road


Name of Street	Location
Covered Bridge Road [Added 10-3-2007 by Ord. No. 2007-11]	Pleasant Valley Road to Cedar Sauk Road
Horns Corners Road	Between Pioneer Road (also designated County Trunk Highway C) and Washington Avenue
Washington Avenue [Repealed 11-7-2007 by Ord. No. 2007-14]	

(2) A speed limit of 35 miles per hour on the following highways:

Name of Street	Location
Bridge Street [Added 1-7-2008 by Ord. No. 2008-3]	From the City of Cedarburg corporate limits west to Granville Road
Cedar Creek Road	From its intersection with County Trunk Highway I westerly for a distance of <u>4 mile 3,100 feet.</u>
Covered Bridge Road	From State Trunk Highway 60 to Pleasant Valley Road
Hannemann Road	From County Trunk Highway I to Cedar Sauk Road
Kaehlers Mill Road [Amended 1-7-2008 by Ord. No. 2008-2]	From 600 feet east of Horns Corners Road to Covered Bridge Road
Maple Road	From Cedar Creek Road to Cedar Sauk Road
Pleasant Valley Road	From Maple Road to a point 0.3 mile west and from County Trunk Highway I to Covered Bridge Road
Washington Avenue [Added 11-7-2007 by Ord. No. 2007-14]	From the City of Cedarburg corporate limits to its intersection with Sycamore Drive

This ordinance shall be in full force and effect upon its passage and posting as provided by law.
