

**TOWN OF CEDARBURG
ORDINANCE NO. 2010-6**

**An Ordinance to Amend Section 16-5 Recreation Commission, of the Town of Cedarburg
Code of Ordinances, Ozaukee County, Wisconsin.**

WHEREAS, the Town of Cedarburg is a municipal body corporate and politic within Ozaukee County; and

WHEREAS, the Town has established a Town recreation program as of January 1, 2010; and

WHEREAS, the Town and City of Cedarburg no longer participate in a shared services agreement for recreation programming through the Cedarburg Recreation Department as of January 1, 2010, and therefore the Town of Cedarburg no longer has representation on the Leisure Services Commission; and

WHEREAS, the Town and City of Cedarburg do participate together in the operation of the Cedarburg Community Pool, via a shared service agreement; and

WHEREAS, the City of Cedarburg has amended their municipal Code of Ordinances to create a Community Pool Commission to act in an advisory capacity to the Cedarburg Common Council in regards to the Cedarburg Community Pool,

NOW, THEREFORE, BE IT ORDAINED by the Town Board of the Town of Cedarburg, Ozaukee County, Wisconsin, that Section 16-5 Recreation Commission, of the Town of Cedarburg Code of Ordinances is hereby amended to read as follows:



§ 16-5. Community Pool Commission Recreation Commission.


The Town of Cedarburg makes appropriations to the ~~Recreation Commission~~ of the City of Cedarburg which permits the residents of the City of Cedarburg and Town of Cedarburg to engage in the various pool related recreational activities under the auspices of the City of Cedarburg ~~Recreation Community Pool Commission~~. Under arrangements made, the Town of Cedarburg has been entitled to have two regular members and one alternate member of the Recreation Community Pool Commission representing the Town of Cedarburg. For so long as this arrangement continues, the Town Chairperson of the Town of Cedarburg, with confirmation of the Supervisors, shall appoint said members of the Recreation Community Pool Commission for such term as shall be designated. The members so appointed shall be residents of the Town of Cedarburg. Editor's Note: Original § 2-5-6, City and Town of Cedarburg Disposal Commission, which immediately followed this section, was deleted at time of adoption of Code (see Ch. 1, General Provisions, Art. II).

This ordinance shall be in full force and effect upon its passage and posting as provided by law.
